REPORT OF THE INSPECTION COMMITTEE CONSTITUTED FOR INSPECTION OF GOVT.COLLEGE OF COMMERCE FOR WOMEN, BHAGWATI NAGAR, JAMMU FOR RENEWAL/EXTENTION OF TEMPORARY AFFILIATION FOR THE SESSION 2021-22.

The committee constituted vide order No. CDC/2021/4522-28 dated 15.11.2021 reached the college premises on 15.3.2022 at 3.30 P.M. for its inspection. The college has already been informed of the proposed date of inspection by the office of the College Development Council vide communication No. CDC/2022/8086-88 dated 10.3.2022. The Director, Colleges Development Council joined the team through on-line mode.

After preliminary interaction with the Principal, teaching staff and after scrutinizing the documents submitted by the college to the University, the committee observed that :

- The college is running in the Pre-Fabricated structure constructed on the land allotted to the college.
- The construction of the building of the college is in progress and likely to be completed in the next financial year.
- The college has enrolled 281 students in current session .
- The college has procured furniture and has also procured the books.
- The college has 09 permanent faculty members including Principal and 01 adhoc faculty member.
- The committee also took around of Library and observed that all the books are properly catalogued.
- Available lecture halls and infrastructure is sufficient to accommodate the present strength of students.
- Separate toilets for boys and girls have been constructed.
- However, a chowkidar is required to be appointed to watch at night.

 **RECOMMENDATIONS:**

Keeping in view the above facts, the committee recommends grant of temporary affiliation in favour of Govt. College of Commerce for Women,

Bhagwati Nagar, Jammu for the session 2021-22. The construction of college building should be completed before the start of next session.
